I understand that once accepted, booth fees are not refundable, whether an exhibitor cancels after submitting an application, or if the Festival is postponed to its rain date, or if the Festival is canceled because of inclement weather. The only exception to our refund policy is if the Festival is canceled due to COVID-19. In this case the WCNA will refund all deposits.
