Payment must be made before acceptance. Payment can be made by Venmo at **@WCNA-FBTL** or by check made payable to the **WCNA**.

I understand that once accepted, booth fees are not refundable, even if the exhibitor cancels after submitting an application. If the Festival is canceled due to rain the WCNA will refund 50% of the booth fee. If the Festival is held and there is rain later in the day no refund will be made.
