Payment must be made before acceptance. Payment can be made by Venmo at **@WCNA-FBTL** or by check made payable to the **WCNA**. If the Festival is canceled due to rain the WCNA will refund 50% of the booth fee. If the Festival is held and there is rain later in the day no refund will be made.

The Applicant agrees to indemnify and hold harmless the Town of Wakefield, Wakefield Center Neighborhood Association, Inc. and its officers and members from any and all claims and judgments for personal injuries or damage to property resulting directly or indirectly from the activities in connection with which permission is given to participate in the Festival by the Lake, and from any costs and expenses to which the Town of Wakefield, the Wakefield Center Neighborhood Association, Inc., and its officers and members may be subjected or which they may suffer or incur by reason thereof. The Applicant further agrees to comply with the pertinent provisions of the Town of Wakefield bylaws and the laws of the Commonwealth of Massachusetts.
